TRANSITIONAL HOUSING (TH)

1. Length of Stay: **Average length of stay of no more than 240 days**
2. Receipt of Non- cash Benefits: **At least 75% of households will receive at least one source of non-cash benefits at program exit**
3. Income Growth: **At least 28% of households will gain or increase employment or non-employment cash income during the reporting period or at exit**
4. Exits to Permanent Housing: **At least 83% of households will move into permanent housing at exit**

2. Non Cash Benefit: **At least 75% of households entering a PSH project will receive at least one source of non-cash benefits from program entry to program exit**
3. Income Growth: **At least 30% of households entering a PSH project will gain or increase employment or non-employment cash income during the reporting period or at exit**
4. Exits to Permanent Housing: **At least 90% of clients will remain in PSH or exit to Permanent Housing as of the end of the reporting period or at program exit**

3. Non Cash Benefits at Exit: **At least 50% of households in ES projects will receive at least one source of non-cash benefits at program exit**
4. Income Growth: **At least 18% of households in ES projects will gain or increase employment or non-employment cash income during the reporting period or at exit**
5. Exits to Permanent Housing: **At least 40% of households in ES projects will move into permanent housing at exit**

RAPID REHOUSING PROJECTS (RRH)

1. Length of Stay: **Projects will have an average household length of stay of no more than 150 days**
2. Health Insurance: **At least 85% of households in RRH projects will receive at least one source of health insurance at program exit**
3. Non Cash Benefits: **At least 70% of households in RRH projects will receive at least one source of non-cash benefits at program exit**
4. Income Growth: **At least 18% of households in RRH projects will gain or increase employment or non-employment cash income during the reporting period or at exit**
5. Rapid Placement for RRH: **Projects will place households into permanent housing within 21 days of project entry**
6. Exits to Permanent Housing: **At least 83% of households entering RRH projects will remain in permanent housing at exit**
